

BRIEF REVIEW of some FEDERAL AGENCIES, LAWS, and FUNDING VICTIM SERVICES IN ARKANSAS

RFP – Request for Proposal

Family Violence Prevention Services Act (FVPSA) - Primary federal funding stream dedicated to supporting emergency shelters and related assistance for victims of domestic violence and their children.

Children's Justice Act (CJA) - Provides grants to States to improve the investigation, prosecution, and judicial handling of cases of child abuse.

Services • Training • Officers • Prosecutors (STOP) Violence Against Women Act - Federal grant funds are awarded to the State of Arkansas to support projects statewide that develop and strengthen effective law enforcement and prosecution strategies and victim services in cases involving violent crimes against women. Federal legislation requires the state to apply funds within the following five categories: (1) Prosecution; (2) Law Enforcement; (3) Courts; (4) Non-Profit Victim Services, and (5) Discretionary.

Sexual Assault Services Program (SASP) - The purpose of SASP is to provide intervention, advocacy, accompaniment, support services and related assistance for adult, youth, and child victims of sexual assault, family and household members of victims, and those collaterally affected by the sexual assault.

Rape Prevention and Education Program (RPE) - RPE formula grants, administered by the CDC Injury Center, provide essential funding to states and territories to support rape prevention and education programs conducted by rape crisis centers, state sexual assault coalitions, and other public and private nonprofit entities.

Victims of Crime Act (VOCA) - Federal grant funds are awarded to the State of Arkansas to support crime victim assistance projects statewide that expand and enhance direct services to victims of crime and provide training and technical assistance to service providers.
